 - Roles, rights and responsibilities of non-executive Directors, including Independent Directors under the Companies Act, 2013, Listing Agreement/SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other regulations.
 - Changes in corporate governance and other regulatory requirements related to the Company and its Directors
 - Other developments / information relevant and meaningful to the Company / Industry / Directors.
- 3. The Company holds dedicated programmes to familiarize its Directors whenever there is a major change in regulations. Towards this end, on

25th March, 2015, the Company held a special separate session from 11.00 a.m. to 01.00 p.m. for Independent Directors to familiarize them about their roles, functions and responsibilities under the Companies Act, 2013 and the Listing Agreements. The Independent Directors were also informed in detail about the requirements related to performance evaluation of the Board as a whole, Committees of Directors, Independent Directors and other Directors. External professional assistance was made available to the Directors for evolving the performance evaluation process.

The Company held a Board Meeting on 16th December, 2010 at its Bhavnagar Plant, the Company's largest manufacturing unit. After the Board Meeting, the Directors visited different Plants at the location and were apprised of the products manufactured, various processes, manufacturing, infrastructure, research and development activities, new products being worked upon etc. The Directors also had fruitful interaction with the operational personnel of the Plant. It will be the Company's endeavor to hold Board Meetings at Plant locations, whenever feasible, to enable the Directors to familiarise with the Company's manufacturing operations, processes and infrastructure.
